

PRIVACY POLICY

Hugh Pearl (Land Drainage) Ltd understands that your privacy is important to you and that you care about how your personal data is used and shared online. Any personal data We do collect will only be used as permitted by law.

1. Definitions and Interpretation

In this Policy, the following terms shall have the following meanings:

“personal data”

4. Your Rights

4.1

4.1.1

4.1.3

The right to rectification if any personal data We hold about you is inaccurate or incomplete (please contact Us using the details in section 9);

4.1.4

The right to be forgotten - i.e. the right to ask Us to delete any personal data We hold about you (We only hold your personal data for a limited time, as explained in section 6 but if you would like Us to delete it sooner, please contact Us using the details in section 9);

4.1.5

The right to restrict (i.e. prevent) the processing of your personal data;

4.1.6

The right to data portability (obtaining a copy of your personal data to re-use with another service or organisation);

4.1.7

The right to object to Us using your personal data for particular purposes; and

4.1.8

Rights with respect to automated decision making and profiling.

If you have any cause for complaint about Our use of your personal data, please contact Us using the details provided in section 9 and We will do Our best to solve the problem for you. If We are unable to help, you also have the right to lodge a complaint with the UK's supervisory authority, the Information Commissioner's Office.

4.3

5. What Data Do We Collect?

5.1

Subject to section 5.2, We do not collect any personal data from you. We do not place cookies on your computer or device, nor do We use any other means of data collection.

5.2

If you send Us an email, We may collect your name, your email address, and any other information which you choose to give Us.

How Do We Use Your Data?

6.1

If We do collect any personal data, it will be processed and stored securely, for no longer than is necessary in light of the reason(s) for which it was first collected. We will comply with Our obligations and safeguard your rights under GDPR at all times. For more details on security see section 7, below.

6.2

As noted above, We do not generally collect any personal data. If you contact Us and We obtain your personal details from your email, We may use them as follows:

6.2.1

To reply to your email;

Any and all emails containing your personal data will be deleted no later than 6 months after you have contacted us

6.4

You have the right to withdraw your consent to Us using your personal data at any time, and to request that We delete it.

We will not share any of your data with any third parties for any purposes.

7. How and Where Do We Store Your Data?

7.1

We only keep your personal data for as long as we need to in order to use it as described above in section 6, and/or for as long as We have your permission to keep it.

Your data will only be stored in the UK.



Data security is very important to us, and to protect your data We have taken suitable measures to safeguard and secure any data We hold about you (even if it is only your email address).

Steps We take to secure and protect your data include:

Paper information is locked away, Data stored on a computer is backed up online to the cloud. All computers are shut down/logged off every night and password protected.
